PLEASE READ

DEAR TAXPAYER:

West Virginia law requires the Assessor to collect a license tax on all dogs in the county in which they reside. Kennel licenses have been removed and are no longer available through the county or state.

Any person who owns a dog, which is generally considered to be vicious, for the purpose of protection, shall acquire a special license from the county assessor. The fee is \$10.00 plus the regular license fee.

West Virginia law requires the Assessor to collect a license tax on all dogs over 6 months of age. Dog Kennel applications and fee schedules are available in the Assessor's Office.
